BAC RESOLUTION DECLARING THE BIDDER WITH THE SINGLE CALCULATED RESPONSIVE BID AND RECOMMENDING AWARD THERETO RESOLUTION NO. 25-0198A

WHEREAS, the DPWH-Isabela Third District Engineering Office advertised the Invitation to Bid for the above-stated Contract through posting in the DPWH website and in the PhilGEPS Website during the period May 31, 2025-June 24, 2025 and in a conspicuous place at the premises of the DPWH-Isabela 3rd District Engineering Office continuously for 7 days starting on May 31, 2025;

WHEREAS, in response to the said Invitation, the BAC received one (1) bid for the Contract;

WHEREAS, on **June 24**, **2025**, after opening the bids, the BAC conducted the Eligibility Check and found one (1) bidder eligible;

WHEREAS, of the bids from the eligible bidders, one (1) bid passed the preliminary examination by the BAC of the Technical and Financial Proposals based on the presence of the submitted documents as against the checklist of required documents, and, consequently, the BAC read and recorded the bid as follows:
