WHEREAS, the DPWH Cebu 2nd District Engineering Office advertised the Invitation to Bid for the above stated Contract and posted the same at the websites of the DPWH, PhilGEPS and at a conspicuous place within the premises of the DPWH Cebu 2nd District Engineering Office continuously for seven calendar days starting on **May 31, 2025**.

WHEREAS, in response to the said Invitation, the BAC received one (1) bid for the Contract as of the deadline for the submission of Bids on **June 23, 2025**;

WHEREAS, on **June 23, 2025**, the BAC conducted, opened, and undertook the Preliminary Examination of the Technical Components of the Bid, and the result as follows:
