K0717+994, BRGY. NAMALTUGAN, CALANASAN, APAYAO**

**RESOLUTION NO. 06-0026-2025**

**WHEREAS**, the DPWH-Apayao 2nd District Engineering Office advertised the Invitation to Apply for Eligibility and to Bid for **CONTRACT ID 25PC0046: REHABILITATION ALONG CLAVERIA-CALANASAN-KABUGAO ROAD, K0717+750-K0717+994, BRGY. NAMALTUGAN, CALANASAN, APAYAO** in the DPWH Website on March 4-11, 2025, PhilGEPS and in a conspicuous place at the premises of the DPWH-Apayao 2nd District Engineering Office on March 4-24, 2025;

**WHEREAS**, the advertised Approved Budget for the Contract (ABC) is ₱ 40,530,000.00;

**WHEREAS**, in response to the said Invitation, the BAC received one (1) bid for the Contract;

**WHEREAS**, on **March 24, 2025**, the BAC conducted the Eligibility Check and found ONE (1) bidder eligible;

**WHEREAS**, on **March 24, 2025 at 2:00 P.M.**, the BAC convened and opened the bid of the eligible bidder;

**WHEREAS**, of the bid from the eligible bidder, one (1) bid passed the preliminary examination by the BAC of the Technical and Financial Proposals based on the presence of the submitted documents as against the checklist of required documents, and, consequently, the BAC read and recorded their bid;

**WHEREAS**, the BAC, with the assistance of its Technical Working Group, conducted the detailed evaluation of the abovementioned bid on March 28, 2025;

**WHEREAS**, on **April 16, 2025**, the BAC issued Resolution No. 04-P-2025-0043, declaring the bidder with the single calculated responsive bid and Notice of Award will be issued after the lift of the Election ban and until the release of Special Allotment Release Order (SARO).

**WHEREAS**, the procurement of the above-stated project will not be feasible due to **non-release of fund**, hence, declaration of failure of bidding is necessary pursuant to Section 41.c. of the 2016 Revised Implementing Rules and Regulation of the Republic Act 9184 which provides that *"The HoPE reserves the right to reject any and all bids, declaring a failure of bidding, or not award the contract in the following situations: c) For any justifiable and reasonable ground where the award of contract will not redound to the benefit of the GoP, as follows: (i) if the physical and economic conditions have significantly changed as to render the project no longer economically, financially, or technically feasible, as determined by the HoPE; (ii) if the project is no longer necessary as determined by the HoPE; or (iii) if the source of funds for the project has been withheld or reduced through no fault of the Procuring Entity.;*
