Interested consultants must submit their Eligibility Documents on or before **April 1, 2024** until **10:00AM** at **BAC office**. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.

The BAC shall draw up the short list of consultants from those who have submitted *Expressions of Interest and Eligibility Documents* and have been determined as eligible in accordance with the provisions of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR).

The short list shall consist of **Three (3) to Five (5)** prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

The Procuring Entity shall evaluate bids using the *Quality-Cost Based Evaluation/Selection (QCBE/QCBS)*, procedure. Only bids whose technical proposals pass the minimum technical evaluation score of **Eighty percent (80%)** shall have their financial proposal opened and evaluated. The Technical and Financial proposal shall have weights of **Sixty-Five Percent (65%)** and **Thirty-Five Percent (35%)**, respectively. The criteria and rating system for the evaluation of bids shall be provided in the instruction to bidders

The contract shall be completed within – **see contract duration above** –.

The Department of Public Works and Highways Camarines Sur 5th, District Engineering Office reserves the right to reject any and all bids, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
