- 1. The Department of Public Works and Highways, Negros Oriental 2nd District Engineering Office, through the release allocation SR2025-02-005073 February 7, 2025 intends to apply the sum of Seven Hundred Fifty Thousand Pesos and 00/100 Only (Php750,000.00) being the Approved Budget for the Contract (ABC) for the payment under Contract ID No. 25CSRH0001 Procurement of Consulting Services for the Conduct of Feasibility Studies/Preliminary and Detailed Engineering/Economic Analysis/Technical Studies/Traffic Impact Assessment - Traffic Condition Assessment of Poblacion -Barras Road, Mabinay, Negros Oriental. Bids received in excess of the ABC shall be automatically rejected at the opening of the Finacial Proposals.
- 2. The Department of Public Works and Highways, now calls for the submission of elegibility documents for:

1. Project:	Consulting Services for the Conduct of Feasibility Studies/Preliminary and Detailed Engineering/Economic Analysis/Technical Studies/Traffic Impact Assessment - Traffic Condition Assessment of Poblacion - Barras Road, Mabinay, Negros Oriental
2. Location	Mabinay, Negros Oriental
3. Objectives:	The main objective of the proposal under this TOR is to determine the viability of the constructed bypass road considering the requirements from the Traffic Condition Assessment (TCA) to be able convert the said local road to national road according to the Department Order No. 112, series of 2024.
4. Outputs/ Deliverables:	 All deliverables shall be submitted in the following manner: 1.1.1 Electronic Copy of the Complete Report consolidated in one PDF file* 1.1.2 Excel File of the Traffic Data Processing in traceable format* 1.1.3 Electronic Copy of the zones used in OD Data Processing, if applicable* Other data/documents to be submitted shall include but not limited to: 2.2.1 Geo-tagged Photographs 2.2.2 Raw and Processed Data of Traffic Survey (Manual Count, Origin – Destination, and Intersection Count) 2.2.3 Overall Accomplishment Reports Final Report/Revised Final Report shall be submitted to DPWH in three copies stored in a document storage box. Electronic file formats (i.e. Microsoft Office, Adobe PDF, AutoCAD, transport input and output files, etc.) of all reports and documents systematically organized in a traceable and auditable format shall be prepared in a DVD and/or CD (3 copies each) and in a USB Flash Drive (1 copy only).

Interested consultants must submit their Applications for Eligibility and Shortlisting not later than 10:00 A.M. on June 4, 2025 at DPWH Negros Oriental 2nd District Engineering Office, Sibulan, Negros Oriental. Application for Eligibility will be evaluated based on a non-discretionary "pass/fail" criterion. The eligibility forms are posted to this REOI at www.dpwh.gov.ph.

- 3. The Terms of Reference (TOR), Request for Expression of Interest (REOI) and Eligibility Forms are now available at DPWH and PhilGEPS websites.
- 4. The BAC shall draw up the short list of Consulting Firms from those who have submitted Eligibility Documents/Expression of Interest and have been determined as eligible in accordance with the provisions of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act," and its Revised Implementing Rules and Regulations (IRR). The short list shall consist of three (3) prospective bidders who will be entitled to submit bids. The criteria and rating system for short listing are:

Experience of the firm	60 pts.
Availability of Required Personnel of the Firm	10 pts.
Workload	30 pts
Total	100 pts.

Eligible bidders must obtain the passing score of eighty (80) points to qualify in the shortlist.

a) Bidding will be conducted through open competitive bidding procedures using nondiscretionary "pass/fail" criterion as specified in the IRR of RA 9184.

Bidding is restricted to Filipino Citizens/Sole Proprietorship, Partnerships, or Organizations with at least sixty percent (60%) interest of outstanding capital stock belonging to citizens of the Philippines.

- b) Pursuant to Republic Act 544, An Act to Regulate the Practice of Civil Engineering in the Philippines and DPWH Department Order No. 195 series of 1992, the Procurement and/or employment of **Corporation/Incorporation** for the practice of civil engineering under locally-funded project **is not allowed**.
- 6. In lieu of the class "A" eligibility documents mentioned under section 8.5.2 of the IRR of RA 9184, the prospective bidder shall only submit a valid and updated PhilGEPS certificate of registration and membership (Platinum) in accordance with section 8.5.2 of the IRR for purposes of determining elegibility. The failure by the prospective bidder to update its certificate with the current and updated class "A" eligibility documents shall result in the automatic suspension of the validity of its PhilGEPS certificate until such time that all the expired class "A" eligibility documents has been updated.
- 7. The Procuring Entity shall evaluate bids using the Quality Cost Based Evaluation/Selection (QCBE/QCBS) procedure. The Technical and Finacial Proposals shall have weights of 65% and 35%, respectively. Only bids whose technical proposals pass the minimum technical evaluation score of Eighty percent (80%) shall have their financial proposal opened and evaluated. The criteria and rating system for the evaluation of bids are provided in the instructions of Bidders.
