1. The Department of Public Works and Highways (DPWH), Davao City II District Engineering Office, through its Implementing Unit, Planning and Design Section, has received financing (herein called "funds") from the Government of the Philippines (hereinafter called the "funding source") towards the cost of the **Consultancy Services for the Geotechnical Exploration for A) Construction of Multi-Purpose Building at Ampon National High School, Barangay Wines, Baguio District, Davao City B) Construction of Multi-Purpose Building at Barangay Subasta, Calinan District, Davao City C) Construction of Multi-Purpose Building (Two-Storey), Regional Training Center 11, Mintal, Davao City, Davao del Sur**. The Procuring Entity intends to apply a portion of the funds in the amount of **PhP540,000.00**, including 5% contingency, being the Approved Budget for the Contract (ABC) to eligible payments under the contract for the **Consultancy Services for the Geotechnical Exploration for A) Construction of Multi-Purpose Building at Ampon National High School, Barangay Wines, Baguio District, Davao City B) Construction of Multi-Purpose Building at Barangay Subasta, Calinan District, Davao City C) Construction of Multi-Purpose Building (Two-Storey), Regional Training Center 11, Mintal, Davao City, Davao del Sur** for which this Bidding Documents is issued.

With the approval of Resolution No. CS-2024-0011 Recommending the Use of Negotiated Procurement (Small Value Procurement) for the above-mentioned project by the District Engineer of Davao City II District Engineering Office on January 15, 2024, we are requesting you to submit one (1) original and one (1) copy of Technical and Financial Proposals for the said services.
