REQUEST FOR EXPRESSION OF INTEREST (REI) FOR

The DPWH, ZN 1st District Engineering Office, Segabe, Piñan, Zamboanga del Norte, through the CY 2025 PDE Funds intends to apply the sum of One Million Five Hundred Twenty Nine Thousand Nine Hundred Eighty Pesos and Ninety One Centavos Only (Php 1,529,980.91) being the Approved Budget for the Contract (ABC) to payments under the contract for ~~25CSJB01 – Geotechnical and Geological Survey/Investigation for the Construction/Completion of Five (5) Units of Multi-Purpose Building, Widening/Replacement of Two (2) Units of Bridge, and Construction of Four (4) Units of Flood Mitigation Structure~~, Bids received in excess of the ABC shall be automatically rejected at the opening of the Financial Proposals.

1. The DPWH, ZN 1st Engineering District, Segabe, Piñan, Zamboanga del Norte, now calls for the submission of "Expressions of Interest and accomplished Eligibility Documents for

Objectives	1 To explore the sub-surface conditions of the area to provide general data relating to the project;
	2 To give an outline of the surface and subsoil geology;
	3 To analyze the data obtained and give engineering consideration and recommendation on the selection and design of foundation;
	4 To prepare the detailed geotechnical and geological investigation of the Multi-Purpose Buildings, Bridges, and Flood Mitigation Structures for the preparation/construction; and
	5 To be able to provide a detailed sub-soil technical report.

Prospective bidders must submit their Eligibility Documents on or before **10:00 AM on March 24, 2025** at **BAC Office, Segabe, Piñan, Zamboanga del Norte**. Application for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.

The Terms of Reference (TOR), Request for Expression of Interest (REI) and Eligibility Forms are now available at DPWH and PhilGEPS Websites.

2. A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of non-refundable fee for the Bidding Documents in the amount of **Php 5,000.00** from **March 13, 2025 – April 14, 2025 until 10:00 AM**, it may also be downloaded free of charge from the www.dpwh.gov.ph and PhilGEPS website, provided that the bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

3. The BAC shall draw up the short list of consultants/firms from those who have submitted EIEDSFs and have been determined as eligible in accordance with the provisions of Republic Act (RA) No. 9184, otherwise known as the "Government Procurement Reform Act", and the Implementing Rules and Regulations (IRR).

3.1 Experience of the Firm (must have at least 50% experience with BAC) . . .	35%
3.2 Qualification of Key Personnel (must have accreditation as Specialist in Geotechnical Engineering and Key Technical Personnel.)	40%
3.3 Job Capacity (must have a laboratory and drilling equipment)	25%

4. Prospective bidders must indicate the amount of any of the consulting services listed below for projects undertaken by the firm (DPWH-CONSL-06(TPF2A)-2016): Technical aspects: Experience on Completed Projects, GOVERNMENT AND PRIVATE) and of the proposed Team Leader/Project Manager (Curriculum Vitae) on the Eligibility Screening Forms

6.1	Geotechnical Investigation/Surveys
6.2	Soil Exploration/Investigation (Including /sub-surface Soil Exploration)
6.3	Preliminary Engineering Design (PED) if Soil Investigation are included therein Soil Exploration/Investigation (Including Sub-surface Soil Exploration)
6.4	Feasibility Study (FS) if Soil Investigation are included therein
6.5	Detailed Engineering Design (DED) if Soil Investigation are included therein

5. Mandatory submission of PhilGEPS Certificate of Registration and Membership (Platinum Membership) as Class "A" document will no longer be a requirement in the determination of the Eligibility of the prospective bidders per GPPB Resolution No. 26-2017, dated July 31, 2017. In lieu of the above, prospective bidders are required to submit all Class "A" eligibility documents stated under Section 24.1 (a) of 2016 Revised Implementing Rules and Regulations (IRR), using the forms prescribe in the Eligibility and Bidding Documents.

6. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criteria as specified in the (IRR) of RA 9184 **on or before 10:00 AM of April 14, 2025** at the **BAC Office, DPWH-ZN 1st DEO, Segabe, Piñan, Zamboanga del Norte**. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.

The procurement and employment of Corporation(s) as consultant(s) for this project is **NOT ALLOWED**

7. The Procuring Entity shall evaluate bids using the Quality Cost Base Evaluation/Selection (QCBE) Procedure. The Technical and Financial Proposals shall have weights of Sixty percent (60%) and Forty percent (40%), respectively. Shortlisted bidders whose technical proposal pass the minimum technical score of seventy-five (75%) shall be invited for the opening of financial proposal and negotiation. The criteria and rating system for the evaluation of bids are provided in the Instructions to Bidders.

8. The contract shall be completed within **Thirty (30) Calendar Days**.
9. The **DPWH, ZN 1st Engineering District, Segabe, Piñan, Zamboanga del Norte**, reserves the right to reject any and all bids, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
10. Bidders are prohibited from making or accepting any communication with Members of the BAC, its staff and personnel, Secretariat, Technical Working Group (TWG) and/or observers, regarding matters connected to their bids from submission and receipt of bids until the approval by the Head of the Procuring Entity (HOPE) of the ranking of the bidders per Section 33.1 of 2016 Revised IRR of R.A. 9184. However, the BAC, through its Secretariat, may ask in writing the bidder for a clarification of its bid. All responses to the request for clarification shall be in writing.
11. The Department of Public Works and Highways reserves the right to reject any and all bids, annul the bidding process, or not award the contract at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
