REQUEST FOR EXPRESSION OF INTEREST

1. The Department of Public Works and Highways Davao del Norte District Engineering Office, Tagum City, through the Bids and Awards Committee (BAC) intends to apply the sum for payments for the project under NEP FY 2025 (EPA) for Consulting Services, wherein GPPB, Circular No. 06-2019 dated July 17, 2019 specially section 2.5 applies, to wit:

Bids received in excess of the ABC shall be automatically rejected at Bid Opening.

2. The Department of Public Works and Highways Davao del Norte District Engineering Office, Tagum City, now calls for the submission of eligibility documents for the above-mentioned description of works. Interested consultants must submit their eligibility documents on or before **October 23, 2024 until 10:00 am** at DPWH, Davao del Norte District Engineering Office, Tagum City. Applications for eligibility will be evaluated based on a non-discretionary "pass/fail" criterion.
3. The BAC shall draw up the list of consultants from those who have submitted eligibility documents/Expression of Interest and have been determined as eligible in accordance with the provisions of Republic Act 9184 (RA 9184), otherwise known as "The Government Procurement Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of five (5) prospective bidders who will be entitled to submit bids.

4. The criteria and rating system for short listing as per D.O. 143, series of 2022, are:
 1. Experience of the Firm – 60 pts.
 2. Availability of Required Personnel of the Firm – 10 pts.
 3. Current Workload Relative to Capacity – 30 pts.
5. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the IRR of RA 9184.

Bidding is restricted to Filipino Citizens/sole proprietorships, partnership, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines.
6. These projects are undertaken thru Early Procurement Activities. The award of contract for these projects may be made only upon approval and effectivity of GAA as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184) Appendix 31 - Guidelines on the Implementation of Early Procurement Activities (EPA).
7. The Procuring Entity shall evaluate bids using the Quality Cost Based Evaluation/Selection (QCBE/QCBS) procedure. The Technical and Financial Proposals shall have weights of 65% and 35%, respectively. The criteria and rating system for the evaluation shall be provided in the Instructions to Bidders.
8. If at the time of the post-qualification procedure, the BAC verifies that any of the deficiencies is due to the contractor's fault or negligence pursuant to 34.3(b)(ii)(c) of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, the Procuring Entity shall disqualify the contractor from the award without any right to reimburse fees and incidental cost paid for the procurement of consulting services subject of the Bid.

Bid Proposals may be submitted through an authorized representative together with a Company ID or Any Government Issued ID and the Original Authorization Letter (*i.e. Special Power of Attorney for Sole Proprietorship; or Board/Partnership/Joint Venture Resolution with Secretary's Certificate for Corporation/Partnership/Joint Venture/Cooperative*) **with attached confirmation from the Owner/AMO of the firm through their registered email address for the authenticity and veracity of said Authorization Letter.**
