THIS AGREEMENT, made this ____ day of JUN 10 2025, by and between:

DPWH-Regional Office I with main office address at Aguila Road, City of San Fernando, La Union, represented herein by REGIONAL DIRECTOR RONNEL M. TAN, hereinafter called the "Entity,"

and

K'S Construction Materials Testing Center with main office address at #99 As-Is, Bauan, Batangas, represented herein by MR. JORDAN L. MALOCONG, hereinafter called the "Consultant."

WHEREAS, the Entity is desirous that the Consultant execute the Consultancy Service for the Conduct of Geotechnical Investigation for Various Flood Control Projects in La Union with contract ID 25CSA051 (hereinafter called "the Works"), and the Entity has accepted the bid for One Million Three Hundred Eighty Thousand Pesos (Php1,380,000.00) by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

WHEREAS, the whole of the works of the Project as covered by this Contract shall be completed within the period of Fourteen (14) CALENDAR DAYS, reckoned from the Effectivity Date of Contract, based on the Notice to proceed (NTP) to be issued by the EMPLOYER to the CONTRACTOR.

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:

- (c) Request for Expression of Interest;
- (d) Instructions to Bidders;
- (e) Bid Data Sheet;
- (f) Addenda and/or Supplemental/Bid Bulletins, if any;
- (g) Bid forms, including all the documents/statements contained in the Bidder's Technical and Financial Proposals, as annexes;
- (h) Eligibility Requirements, Documents and/or Statements;
- (i) Performance Security;
- (j) Notice of Award of Contract and the Bidder's conforme thereto;
- (k) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.
