DPWH-Regional Office I with main office address at Aguila Road, City of San Fernando, La Union, represented herein by REGIONAL DIRECTOR RONNEL M. TAN, hereinafter called the "Entity,"

and

Groundworkz Geotechnical Testing Services with main office address at San Vicente, Urdaneta City, Pangasinan, represented herein by MR. NICK MAMARIL, hereinafter called the "Consultant."

WHEREAS, the Entity is desirous that the Consultant execute the Consultancy Service for the Conduct of Geotechnical Investigation for Various Bridge Projects in Region I with contract ID 25CSA055 (hereinafter called "the Works"), and the Entity has accepted the bid for One Million Three Hundred Forty Nine Thousand Five Hundred Eighty Two Pesos and Fifty Five Centavos (Php1,349,582.55) by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

WHEREAS, the whole of the works of the Project as covered by this Contract shall be completed within the period of Twelve (12) CALENDAR DAYS, reckoned from the Effectivity Date of Contract, based on the Notice to proceed (NTP) to be issued by the EMPLOYER to the CONTRACTOR.

- (j) Notice of Award of Contract and the Bidder's conforme thereto;
- (k) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.
