### CONTRACT AGREEMENT

WHEREAS, the Entity is desirous that the Consultant for the **Geotechnical Investigation (Soil Exploration) of various Road Projects, 5<sup>th</sup> Legislative, Iloilo** (hereinafter called "the Works"), and the Entity has accepted the bid **One Hundred Twenty Nine Thousand Pesos (P 129,000.00)** by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

  - (g) Bid forms, including all the documents/statements contained in the Bidder's Technical and Financial Proposals, as annexes;
  - (h) Eligibility Requirements, Documents and/or Statements;
  - (i) Performance Security;
  - (j) Notice of Award of Contract and the Bidder's conforme thereto;
  - (k) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Consultant as hereinafter mentioned, the Consultant hereby covenants with the Entity


to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Consultant in all respects.


