**WHEREAS**, the Department of Public Works and Highways, Cagayan Third District Engineering Office thru this Procuring Entity, is procuring the above mentioned Contract using the Quality Cost Based Evaluation (QCBE) system in accordance with the provisions pf Republic Act (RA) No. 9184 and Its Implementing Rules and Regulations (IRR);

**WHEREAS**, the procurement of the said Contract has undergone the required process provided in RA 9184-IRR, and the OIC District Engineer – Esmeralda O. De Guzman approved on June 11, 2025 the attached Resolution No. 2025-06-04 of this Bids and Awards Committee (BAC) recommending the declaration of CISSANA CONSTRUCTION MATERIALS TESTING CENTER as the Bidder with the Highest Rated Bid (HRB).


**WHEREAS**, the Bids and Awards Committee (BAC) successfully conducted negotiations with the Bidder with the Highest Rated Bid (HRB) on June 16, 2025 in accordance with the provisions of Section 33.5 of RA 9184-IRR, resulting in Total Contract Cost of **Four Hundred Forty Seven Thousand Forty Seven Pesos and Twenty Nine Centavos (P447,047.29)** which is below the Approved Budget for the Contract (ABC) in the amount of **P450,450.00**; and;


**WHEREAS**, the Bidder with the Highest Rated Bid (HRB) passed the Post-Qualification conducted by the BAC on June 17, 2025 to June 19, 2025 in accordance with the provisions of Section 34 of RA 9184-IRR;

**NOW, THEREFORE**, We the Members of the Bids and Awards Committee (BAC), hereby **RESOLVE**, as it is hereby **RESOLVED**:






