

- 1. All entries must be typewritten or legibly written.
- 2. Delivery period: within 15 C.D. upon receipt of the approved funded Purchase Order (P.O). Administrative penalties pursuant to Sec. 69 of the Revised IRR-RA 9184 shall be imposed for non-delivery without valid reason.
- Warranty shall be for a minimum of three (3) months for supplies & materials;
 One (1) year for Equipment; three (3) years for IT Equipment from date of
 Acceptance by the end-user.
- 4. Price validity shall be for a period SIXTY (60) C.D.
- 5. VALID BIR Certificate of Registration, PhilGEPS Registration Number, Omnibus Sworn Statement (for ABC above 50k; GPPB Revised Form) & Income Tax/Business Returns (for ABC above 500k) shall be attached upon submission of the quotation. The Audited Financial Statement, DTI Business/SEC Registration Certificate, Tax Clearance and Mayor's/Business Permit shall be submitted upon the award of contract.
