The Department of Public Works and Highways Regional Office VII, through the DPWH FY 2025 General Appropriation Act (GAA) intends to apply the sum of Php 2,428,535.75 being the Approved Budget for the Contract (ABC) to payments under the contract for Supply, Delivery, & Installation of Audio-Visual System and its accessories for use in the ROWALD Office Conference Room, DPWH R.O. 7, SRP, Cebu City, with Contract Id No. 25GH00013; P.R. # 2025-06-0171 dtd. 06-11-2025. Bids received in excess of the ABC shall be automatically rejected at bid opening.

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183
4. Interested bidders may obtain further information from Department of Public Works and Highways Regional Office VII and inspect the Bidding Documents at the address given below from 8:00 A.M. to 5:00 P.M.
5. A complete set of Bidding Documents may be acquired by interested bidders August 07 - 27, 2025 until 10:00 A.M. only from given address and website/s below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Php5,000.00. The Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
