INVITATION TO BID

1. The **DPWH Zamboanga del Norte 1st District Engineering Office**, through the **GOP CY-2024** intends to apply the sum of **Php 2,028,750.00** being the Approved Budget for the Contract (ABC) to payments under the contract for **24GJB0003 – Supply and Delivery of 25,000 ltrs. Automotive Diesel Fuel, 7000 ltrs. Regular Gasoline, etc... for use in the Operation of Service Vehicles, Heavy Equipments and Operation of Brush Cutter in the Maintenance of National Roads in the 1st Engineering District – Segabe, Piñan, Zamboanga del Norte**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **DPWH Zamboanga del Norte 1st District Engineering Office** through its Bids and Awards Committee now invites bids for the hereunder Works:

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". The contract shall be awarded to the Lowest Calculated Responsive Bidder (LCRB) who was determined as such during post-qualification.

Bidding is restricted to Filipino citizen/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizen of the Philippines, and to citizens or organization of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Interested bidders may obtain further information from the **DPWH Zamboanga del Norte 1st District Engineering Office** and inspect the Bidding Documents at **Segabe, Piñan, Zamboanga del Norte** during weekdays from **8:00 am to 5:00 pm**.

5. A complete set of Bidding Documents may be acquired by interested bidders on **July 3, 2024** from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php 5,000.00.**
6. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
7. The **DPWH Zamboanga del Norte 1st District Engineering Office** will hold a Pre-Bid Conference on **July 11, 2024** at **BAC Office, Segabe, Piñan, Zamboanga del Norte.** which shall be open to prospective bidders.
8. Bid submission maybe done manually or electronically/online. However, bidders should only select one mode of submission, either manual or electronic. Similar to manual submission, the guidelines for the preparation and submission of an electronic bid are contained in the **BDS.**
9. Bids must be duly received by the BAC Secretariat at the address below for manual submission or at ***electronicbids_zamboangadelnorte1@dpwh.gov.ph*** for electronic submission on or before **July 23, 2024 @ 10:00 am.** All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.
10. Bid opening shall be on **July 23, 2024 @ 10:01 am onwards** at **BAC Office, Segabe, Piñan, Zamboanga del Norte.** Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
11. The **DPWH Zamboanga del Norte 1st District Engineering Office** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
