- 2. The Department of Public Works and Highways, Isabela Ist District Engineering Office, City of Ilagan, Isabela now invites bids for the above Procurement Project. Delivery of the Goods stated above is required. Bidders should have completed, within from the date of submission and receipt of bids, a contract similar to the project. The description of an eligible bidder is contained in the Bidding documents, particularly, in Section II (Instruction to Bidders).
- 3. Bidding will be conducted through open competitive bidding procedures using a nondiscretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

Bidding is restricted to Filipino citizens/sole proprietorships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

- 4. Prospective Bidders may obtain further information from Department of Public Works and Highways, Isabela Ist District Engineering Office, City of Ilagan, Isabela and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders on **June 20, 2025 to July 11, 2025** from the given address and website(s) below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB. The Procuring entity shall allow the bidder to present its proof of payment for the fees in person, facsimile, or through electronic means.

- Bid Opening shall be on July 11, 2025 immediately after the deadline of submission of Bids. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

The Department of Public Works and Highways, Isabela Ist District Engineering Office, City of Ilagan, Isabela reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
