BAC RESOLUTION DECLARING CANCELLATION OF CONTRACT ID NO. 24GOH0099 RFQ-SUPPLY OF MYLAR PAPER FOR USE OF PLANNING AND DESIGN SECTION

RESOLUTION NO. G048-2025

WHEREAS, the Department of Public Works and Highways-South Manila District Engineering Office advertised through Small Value of Procurement of the above Request for Quotation at the website of the DPWH and the PhilGEPS and at a conspicuous place at the premises of the Department of Public Works and Highways on June 28, 2025;

WHEREAS, the said project has an Approved Budget of the Contract (ABC) amounting to **Nine Hundred Ninety Four Thousand Five Hundred Pesos Only (PhP 994,500.00)**;

WHEREAS, the End-User informed the BAC Secretariat that there are no available funds for the above-mentioned contract;

WHEREAS, the Bids and Awards Committee (BAC), taking into consideration the End-User's request, promptly convened and agreed to cancel the procurement activity for 24GOH0099 RFQ;

WHEREAS, pursuant to Section 35.6 of 2016 Revised IRR of R.A. 9184 which provides that without prejudice to Sec. 35.1 hereof, the BAC is authorized, upon consultation with the end-user unit, to cancel or terminate the conduct of procurement activities, **for any justifiable reason, such as but not limited to:** a) the physical and economic conditions have significantly changed so as to render the project no longer economically, financially, or technically feasible, as determined by the end-user unit; b) the project is no longer necessary as determined by the end-user unit; **c) the source of funds for the project has been withheld or reduced through no fault of the PE;** or d) brought about by the declaration of a State of Calamity, or implementation of community quarantine or similar restrictions.

NOW, THEREFORE, we, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED that the above-mentioned project be cancelled:
