RESOLUTION DECLARING FAILURE OF BIDDING AND RECOMMENDING RE-ADVERTISEMENT

WHEREAS, the DPWH Camarines Sur 3rd District Engineering Office through its Bids and Awards Committee (BAC), conducted procurement for the project: "**PR 2025-06-0027 (re-ad) - Procurement of Supplies, Preventive Maintenance Materials and Tires of service vehicles for use in Camarines Sur 3rd DEO**" under Small Value Procurement, with an Approved Budget for the Contract (ABC) of Php 673,400.00, pursuant to Section 53.9 of the 2016 Revised IRR of RA 9184;

WHEREAS, the project was first advertised/posted on June 19-25, 2025, but no suppliers submitted their quotation, resulting in a failure of bidding;

WHEREAS, the project was re-advertised and reposted on June 27-July 3, 2025 in accordance with procurement procedures;

WHEREAS, during the scheduled Submission and Opening of Quotations on July 3, 2025, only one supplier, **MIF ENTERPRISE**, submitted a bid;

WHEREAS, upon preliminary examination and evaluation of the documents submitted, MIF ENTERPISED was declared ineligible due to the Omnibus Sworn Statement not being dated, thereby failing to comply with the documentary requirements;

WHEREAS, Section 35.1(b) of the 2016 Revised IRR of RA 9184 states that a failure of bidding shall be declared when "no bid qualifies as eligible or no bid is found to be responsive to the requirements of the bidding documents";

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED to:

- Declare Failure of Bidding for the PR 2025-06-0027 (re-ad) Procurement of Supplies, Preventive Maintenance Materials and Tires of service vehicles for use in Camarines Sur 3rd DEO; and
- Recommend the re-advertisement and re-posting of the project in accordance with the provisions of the 2016 Revised IRR of RA 9184, subject to compliance with all applicable procurement rules and procedures.
