RESOLUTION DECLARING FAILURE OF BIDDING AND RECOMMENDING RE-ADVERTISEMENT

BAC RESOLUTION NO. 20

Series of 2025

WHEREAS, the Bids and Awards Committee (BAC) of the Department of Public Works and Highways – Camarines Sur 3rd District Engineering Office undertook the procurement of PR No. 2025-05-0023 (re-ad) – Procurement of IT Equipment through Small Value Procurement, pursuant to Section 53.9 of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184;

WHEREAS, the first posting of the Request for Quotation (RFQ) was conducted on June 19 to 25, 2025, and the opening of quotations was held on June 25, 2025; however, it resulted in a Failure of Procurement due to non-receipt of any quotations;

WHEREAS, the procurement was subsequently re-advertised and posted for the second time from June 27 to July 3, 2025, through the Philippine Government Electronic Procurement System (PhilGEPS), the DPWH website, and in conspicuous places within the premises of the procuring entity, in accordance with procurement rules;

WHEREAS, only one (1) supplier, Upkeep Non-Specialized Wholesale Trading, submitted a quotation, which was opened on July 3, 2025;

WHEREAS, during the evaluation of the submitted quotation, it was found that the brand indicated for the printer item was "ACER", a non-existent or unrecognized brand for such equipment;

WHEREAS, a letter of inquiry was sent by this Office to Upkeep Non-Specialized Wholesale Trading on July 7, 2025, seeking clarification on the offered printer brand;

WHEREAS, on July 10, 2025, Upkeep Non-Specialized Wholesale Trading replied, stating that the indicated brand "ACER" was a typographical error, and the intended brand was "BROTHER";

WHEREAS, under Section 32.2.4 of the 2016 IRR of RA 9184, bidders may clarify submitted documents only for purposes of verifying information, but no modification to the bid shall be allowed after the deadline for submission, especially when such correction involves technical specifications;

WHEREAS, the BAC determined that the correction from "ACER" to "BROTHER" affects a material component of the bid, and thus constitutes a modification rather than a clarification, rendering the bid non-responsive;

NOW, THEREFORE, we, the Members of the Bids and Awards Committee, hereby RESOLVE as follows:

- a. To declare a Failure of Bidding for the second posting (re-advertisement) of PR No. 2025-05-0023 (re-ad) Procurement of IT Equipment, due to the non-responsiveness of the sole bidder, Upkeep Non-Specialized Wholesale Trading;
- b. To recommend the re-advertisement and re-posting of the Request for Quotation (RFQ) for the same procurement project through PhilGEPS, the DPWH website, and in conspicuous places, in accordance with the provisions of RA 9184 and its IRR.
