Justifications provided by the requesting Implementing Office:

- Adjustments in station limits to merge sections that are continuous but are segmented in the original project description, to omit station limits K0866+893 – K0866+909 since said section is already in 4 lanes, and to omit station limits K0868+560 – K0869+793 since the allocated budget cannot cover the original length considering other essential items based on the design requirements, which resulted to the decrease of physical target for CW1 – Road Widening from 8.355 Lane Km to 5.966 Lane Km with an equivalent unit cost of ₱ 12,870,654.25/ Lane Km.
- 2. The inclusion of new work component, CW2 Construction of Road Slope Protection Structure (stone masonry with steel sheet piles), with a physical target of 9,881.07 square meters and length of 2,993 lineal meters, is integrated into the design to address the need for slope stability within the alignment, acting as support structure which ensures the durability of widened road and other vital structures, for the safety of the travelling public from possible slope collapse and landslide, which arrived the unit cost of ₱ 6,358.12/ square meter.
