JUSTIFICATION:

To specify the actual station limits of the project since it was not provided in the FY 2017 GAA. The physical target was decreased from 0.4 lane km to 0.372 lane km due to the inclusion of Drainage and Slope Protection Structures which represents 22.09% (₱ 432,951.29), and Surface Course of 49.08% (₱ 961,997.72) of the total project cost. Thus, the request for modification.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP 202, Certificate of Availability of Funds (CAF), Approved Program of Work, Approved Budget for the Contract (ABC) and Geotagged photographs.
