Justification:

- Decrease in physical target due to the usage of Furnished and Driven Steel Sheet Pile, Z-Type, Grade 50 with a depth of 9m and a total length of 2,889.00 lm based on the approved DED and POW.
- The use of sheet pile was incorporated in the design to minimize the effect of bending stresses in the piles.
- As per design, to comply to the design flood height requirements, the structure used Z-type steel sheet piles which has a large section modulus of 1355 cubic cm/meter with an embedment length of 9 meters to withstand the water pressure needed for the river protection dike.

- The project also includes earthworks such as Structure Excavation and Embankment (from Borrow) (5.54%).

- The derived unit cost is based on the Approved Plan and Program of Works.
