## JUSTIFICATION:

Modification is requested to indicate the correct station limit of the project based on actual survey/validation in the field and there is a decrease in physical target since the scopes of work involves the furnishing and the driving of structural steel sheet piles for foundation (12m each pile), concrete pile cap, reinforced concrete slope protection combined with rubble concrete and grouted riprap, and hand laid rock embankment, which constitutes 75.65% (₱ 26,573,871.37) and earthworks to 20.50% (₱ 7,201,388.04) of the total project cost, thus the original physical target length decreases by 182.8 lm (from 625 lm to 442.20 lm).

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP202, Program of Work, Certificate of Availability of Funds (CAF), Geotagged Photos, and Typical Plan.

In view of the above, this request for Modification of Project is respectfully recommended for your consideration and approval.
