JUSTIFICATIONS:

1. Road Opening/Construction of Gravel Road was prioritized in order to provide easy access to the tourism destinations with a more comfortable road; and

2. The construction of slope protection works was limited to critical areas, hence, the physical target decreases from 4,884.800 sq. meters to 270.740 sq. meters, in order to give priority to the road opening.

3. The physical target of Concrete Paving/Construction of Concrete Road also decreases in order to give priority to the road opening.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval
