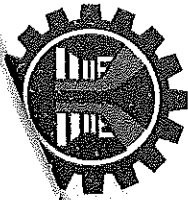

Reason/s for Modification			
- Modification is sought due to the increase in project target length brought about by the proximity of source of aggregate to the project site. - The project location is not flood prone area, hence, existing cross drainage and protection works were only extended. - The decrease in unit cost per sq.m. is brought by cheap cost of aggregates causing the increase in physical target. The original station limits are cut due to existing paved junctions which are already an integral part of the proposed project.			

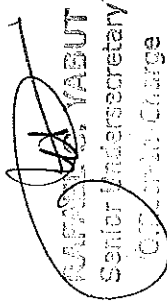
Finding the herein request for modification in order, it is respectfully recommended to the Secretary for his consideration and approval.
