This has reference to the herein Memorandum dated April 5, 2017 of **Director Edgar B. Tabacon, CESO IV**, DPWH Regional Office No. VIII, favourably endorsed the request for project modification of District Engineer Manolo A. Rojas, Eastern Samar DEO, which is included in the FY 2017 GAA, R.A. 10924, to wit:

JUSTIFICATIONS:

- 1. Allocation of Road Right of Way was deleted since same was considered under the FY 2016 Budget.
- 2. The physical targets of the Construction of Concrete Road (CW1) and the Construction of Slope Protection Works (CW2) decrease by 2.666 Lane Km and 305 square meters, respectively, as priority was given to Road Opening or the Construction of Gravel Road (CW3).
- 3. Unit Cost per Lane Km on the Construction of Gravel Road (CW3) increases since Item 102 (2) -Surplus Common Excavation is 72.91% of the total project cost because the project is located in a mountainous terrain and the road cut ranges from 5 meters to 32 meters high.

Attached are the required documents such as Form for Evaluation of Modification Request (2017, version 2.1); Certificate of Availability of Funds; Approved Program of Works; BP 202; Location Map; and Geo-tagged pictures.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
