JUSTIFICATIONS:

Modifications are requested for the following reasons:

- 1. Per actual survey, there is no embankments along the road sides with a height of over 5 meters and with a distance from the toe of the slope to the road less than 5 meters, hence, Construction of Slope Protection Works was deleted.
- 2. Construction of Drainage Structure was added as a Project Component in order to prevent erosion.
- 3. The physical target of the Construction of Concrete Road decreases by 5.1 Lane Km as we give priority to the Road Opening or the Construction of Gravel Road to provide easy access to the people living in the area.
- 4. Road Right of Way (ROW) Cost was already determined.

Attached are the required documents such as Form for Evaluation of Modification Request (2017, version 2.1); Approved Program of Works; BP 202; Location Map; and Geo-tagged pictures.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
