Borromeo** of DPWH-XI, favorably endorsing the approval of the Project Modification of the Davao Oriental 2nd District Engineering Office to be implemented by the said district under the FY 2017 GAA in the prescribed form (2017, version 2.1), to wit:

JUSTIFICATION :

Increase in physical target by 2.546 lane km (from 6.284 lane km to 8.83 lane km) since the road section runs in flat terrain, hence, does not require massive earthworks. The station limits of Section B and Section C was merged and changed into K1773 + 512.20 – 1777 + 563.050 to avoid gaps in between.

Attached are the required documents, such as Evaluation Form (2017 version 2.1), BP 202, Certificate of Availability of Funds (CAF), Approved Program of Work, Straight Line Diagram, and Geotagged photographs.

In view of the above, the request for Modification of the Project is respectfully recommended for the Honorable Secretary's approval.
