## JUSTIFICATION:

Modification is requested due to increase in length from 400 lm to 640 lm due to inclusion of adjacent sections which also need flood mitigation structures to protect the lives and properties along the area. The excavated materials from the river (about 50%) was utilized for embankment inasmuch as it is still suitable for the said purpose, hence, generated excess amount. This said excess amount was utilized for said inclusion/extension of project

limits and payment for RROW. There is additional component (ROW) inasmuch as per actual assessment, there is a need for RROW payment for affected structures/improvements/acquisition.

Attached are the required documents, such as Evaluation Form (2017, version 2.1), BP 202, Certificate of Availability of Funds (CAF), Approved Program of Work and Geotagged photographs.

In view of the above, the request for Modification of the Project is respectfully recommended for consideration and approval.
