Justification:

The modification is hereby sought due to the following reasons;

- The modification in station limits is necessary due to an expanded physical target, which has been determined through on-site validation and survey. It has been found that stations K0215 + 340 -K0215 + 920 require significantly more attention for drainage compared to the initial station limits of K0219 + 436 - K0219 + 650.
- Unit Cost was derived based on the latest approved Construction Materials Price Data (CMPD), Detailed Unit Price Analysis (DUPA) and approved Program of Work.
