Justification:					

- Adjustment in the Station Limits, the rehabilitation of K0085 + (-374.40) K0085 + 758, K0085 + (-684) - K0085 + (-385), K0085 + 768.50 - K0086 + 116 is already included in the modified station of FY 2023 Project (i.e., P00712949LZ).
- This project will serve as continuity of the said FY 2023 Project in order to acquire a continuous good section after the construction stage.
- Increased in the derived unit cost per approved POW and DED consolidated in the latest Construction Materials Price Data.
- The increment in the unit cost was due to the proposed 380mm thick slab, the said design of the slab will provide consistency from the FY 2023 project. Further, since huge volume of traffic and heavy loaded vehicles is being catered by the road section, the design of the pavement will help to withstand the stress caused by the huge volume of traffic and the heavy loaded vehicles.
