## Justification:

Modification is sought due to:

- Change in the station limits to prioritize the inclusion of CW2 (Construction of Road Slope Protection Structure) which is necessary to protect the newly widened road section from erosion which resulted to the decrease in the physical target of CW1 from 1.539 lane km to 0.73 lane km.
- 2. ROW component was already identified for payment of affected lots, structures, and utilities.

3. Attached is a Certification for Reasonableness of Cost dated January 31, 2023.
