

Justifications:

1. Due to insufficient fund allocation to cover the total cost of the original physical target, change in station limits is requested to prioritize road section that needs asphalt overlay in order to prevent further pavement deterioration for the safety of the travelling public.
2. Said changes resulted to the decrease in physical target from 4.802 Lane Km to 3.912 Lane Km and consequently increase in unit cost in view of the inclusion of road safety devices in the scope of works and the effect of the increasing prices of construction materials and equipment rental rates, copy attached is Certificate of Reasonableness of Cost Estimate for your reference and guidance.
3. Attached are the following supporting documents: Form for Evaluation of Modification Request (2023, V1.0); BP 202; Certificate of Availability of Funds; Approved Program of Works; Plan; Geotagged Photos; Certificate of Reasonableness of Cost Estimate; and Location Map
