## Justification:

The modification is sought due to:

- 1. Change in scope of work since the project involves the reconstruction of deteriorated road sections.
- Adjustment in the station limits to prioritize deteriorated road sections resulting to the decrease in physical target of CW1 from 3.06 lane km to 1.804 lane km and increase in unit cost per lane km of CW1.
- 3. Inclusion of CW2 (Construction of Road Slope Protection Structure) in order to protect the newly reconstructed concrete pavement from erosion.
- 4. Attached are the following supporting documents: Approved Program of Works (POW), Detailed Engineering Design (DED), Certificate of Availability of Funds, and GIS Map.
