Justification:

The change in type of work from CW1 - Construction of Concrete Road to CW1 - Construction of Gravel Road is due to the following:

- The change in the type of work from concrete road to gravel road is considered since the road project is a road opening requiring stabilize road base prior to future concreting.
- Inclusion of CW2-Construction of Drainage Structure along Road, which is composed of RCPC and RCBC cross drains, to prevent the impounding of water and to protect the road structure from scouring.
- Inclusion of CW3-Construction of Road Slope Protection Structures, consisting of retaining wall, 911.415 square meters on right side and 2,227.09 square meters on left side, and 18.6 square meters of stone masonry giving a total area of 3,157.105 square meters, on areas where the terrain is a rolling terrain and to hold the road embankment to establish the design grade elevation of the road.
- Inclusion of Road Right-of-Way Acquisition covering 1,666.666 square meters to accommodate four (4) lanes with 30 meters total width and a length of 101.67 meters to compensate affected property owners.

Attached are the following supporting documents: Annexure A to Modification Request Form, GIS Map of the Proposed Project Work Location, BP 202, Certificate of Reasonableness of Estimate, Certification of "No Overlapping" and "Not Within Warranty Period", Geotagged Photographs, Approved Program of Works (POW) with Detailed Unit Price Analysis (DUPA), and Approved Detailed Engineering Design (DED).

Based on our evaluation, the submitted request for modification of the said project is in order; hence, approval hereof is recommended.
