Since the river section is within the Bicol River Basin which is frequently flooded and the river banks are prone to erosion, this flood control structure requires the following design elements: 9-meter deep steel sheet pile, concrete foundation, 5.13-meter high gravity-type bank protection structure, and provision of buttress wall spaced at every 25 meters.

Inclusion of drainage works and miscellaneous safety features (including reinforced concrete box culverts, flood gates, gutter, stairs and railings) which comprises 3.68% of the total estimated cost.;

Additional hauling cost to transport materials; and

Adoption of canvassed prices for particular materials which are affected by extraordinary price
