Justification:

- The change in project title is to reflect the actual scope of work of the project.
- The decrease in unit cost of CW1- Construction of Bridge 1 is based on validated/ approved Detailed Unit Price Analysis (DUPA) and Program of Work (POW).
- The decrease in physical target of CW2- Construction of Bridge 2 is due to the change in bridge length from 30 m to 25 m based on site validation. The increase in unit cost is due to the utilization of Pre-stressed girders for concrete bridge with 25m length and 9.54 m width.

Attached are the following supporting documents: Annexure A to Modification Request Form, GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds, BP 202, Certificate of Reasonableness of Estimate, Certification of "No Overlapping" and "Not Within Warranty Period", Geotagged Photographs, Approved Program of Works (POW) with Detailed Unit Price Analysis (DUPA), and Approved Detailed Engineering Design (DED).
