#### Justification:

- The station limits were modified from K0395 + 931 K0397 + 209, K0401 + 820 K0402 + 000 to K0421 + 000 K0422 + 000, K0435 + 605 K0435 + 738 to give priority to the sections with worse conditions needing asphalt reconstruction. (*Please see attached geo-tagged photos as per validation and survey.*)
- The increase in unit cost/decrease in the physical target of CW1: Rehabilitation of Paved Road: Asphalt Reconstruction from 5.864 lane km to 4.464 lane km is due to the following:
  - Inclusion of re-blocking of dilapidated PCCP from 230 mm thick to 300 mm thick and increase in the thickness of asphalt surfacing from 80 mm to 100 mm.
  - Increase of carriageway lane width from 3.35 m to 3.50 m to conform to the lane configuration as per Memorandum dated October 23, 2023 (Typical Standard Plans for Maharlika Highway).
- Attached are the following supporting documents: GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds (CAF), BP Form 202, Certificate of Reasonableness of Cost Estimate, Certificate of "No Overlapping" and "Not Within Warranty Period", Geotagged Photographs, Approved Program of Works (POW) and Approved Detailed Engineering Design (DED).
