#### **Justification:**

- The increase in physical target is due to the deletion of CW2: Road widening since, the section is located in a
  geographically mountainous area that is ocularly deemed impossible to widen.
- The increase in unit cost is due to the use of items 311 (1) f2: Portland Cement Concrete Pavement (Unreinforced) 0.30m thick 7 days, 206 (1): 0.25 m thick polymer stabilized subbase/base/surface course, and reblocking of dilapidated concrete pavement on shoulders ranging from 1.5 3.0 meters.
- The addition of project limits is due to the prioritization of bad sections needing rehabilitation, and to synchronize with the increase in the physical target. (Please see attached Straight Line Diagram)

Attached are the following supporting documents: GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds (CAF), BP Form 202, Certificate of Reasonableness of Cost Estimate, Certificate of "No Overlapping" and "Not Within Warranty Period", Geotagged Photographs, Approved Program of Works (POW) and Approved Detailed Engineering Design (DED).
