





Justification:

- The decrease in unit cost/increase in physical target for CW1. — Rehabilitation of Paved Road: Asphalt Reconstruction from 2.096 lane-km to 3.3284 lane-km is due to the following:
 - Revised unit cost due to change in scope of work, that is, exclusion of drainage from the original scope of work due to right of way problem.
 - Inclusion of road section K0379 + 000 – K0379 + 358, K0380 + 000 – K0380 + 257, K0382 + (-433) – K0382 + (-215.9) to synchronize with the increase in the physical target.
- The change in the project title was made to state/include the actual limits in the project title to clearly delineate the start and end limits of the project.

Attached are the following supporting documents: GIS Map of the Proposed Project Work Location, Certificate of Availability of Funds (CM), BP Form 202, Certificate of Reasonableness of Cost Estimate, Certificate of "No Overlapping" and "Not Within Warranty Period", Geotagged Photographs, Approved Program of Works (POW) and Approved Detailed Engineering Design (DED).
