- The project includes of miscellaneous structures such metal guardrails, concrete curb and application of reflectorized thermoplastic pavement markings for safety purposes.
- Change in the project limit to synchronize with the increase in the physical target. See attached Straight line diagram.
- Inclusions of CW2: Construction of Road Slope Protection Structure with substantial cost due to the usage of souctural congette with penals and sheet piles. CW2 was included in order to protect the roadway from road slips and soil erosion.
