**What is the measure?**

Percentage of audited projects with absolute accuracy of at least 99% based on the annual cost estimation audit

**What strategic objective is the measure aligned?**

Comply with the latest construction standards

**What is the rationale behind the measure?**

To ensure compliance of DPWH implementing offices to construction standards relative to the preparation of program of works (POW) and approved budget for the contract (ABC). This core process will ensure that the Right Projects are implemented under the Right Cost.

**How is the measure calculated? Clarify the terms in the formula**

$$\text{Absolute Accuracy (\%)} = 100 \times \left( 1 - \frac{|\text{POW as approved by IO} - \text{POW as evaluated by CEAT}|}{\text{POW as approved by IO}} \right)$$

$$\% \text{ Project} = \frac{\text{No. of audited projects with absolute accuracy of at least 99\%}}{\text{Total no. of audited projects}}$$

**What strategic objective is the measure aligned?**

Comply with the latest construction standards

**What is the rationale behind the measure?**

To ensure that Implementing Offices attain minimum physical accomplishment targets set by the Department. This core process will ensure that the Right Projects are delivered Right on Time.

**How is the measure calculated? Clarify the terms in the formula**

(%) IOs =  $\frac{\text{No. of IOs attaining the minimum physical accomplishment target}}{\text{Total No. of Implementing Offices}}$

**What is the measure?**

Percentage of Implementing Offices (IOs) with at least Very Satisfactory (VS) rating in the annual Quality Assurance Audit

**How is the measure calculated? Clarify the terms in the formula**

$$x = \frac{N_{Rating \geq VS}}{P_{Total}} \times 100\%$$

where:

$x$  = % of Implementing Offices with at least Very Satisfactory (VS) rating in the annual Quality Assurance Audit

$N_{Rating \geq VS}$  = Total number of DPWH Implementing Offices (IOs) with at least VS Rating

$P_{Total}$  = Total number of DPWH IOs

**Who is responsible for tracking and reporting the annual accomplishments?**

Bureau of Quality and Safety, and Bureau of Research and Standards

**What strategic objective is the measure aligned?**

Comply with the latest construction standards

**What is the rationale behind the measure?**

An efficient quality assurance in project implementation as translated by acceptable quality assurance rating would result to conformance with construction standards. This core process will then maximize the life span of the infrastructure and eventually reducing maintenance cost.

**What data is required in calculating the measure?**

Report of quarterly QA Audit, DPWH laboratory Star Rating, Project Designation Order, Quality Control Program, Certificate of Quality Control Assurance and Status of Test.

**Where/how will it be acquired?**

From the quarterly audit of the Quality Assurance Unit (QAU) of the Central Office to all IOs, the Bureau of Quality and Safety (BQS) shall evaluate the quality audit reports and provide annual rating per office with its corresponding Adjectival Rating.

**Indicate policy/law that is applicable**

Department Order No. 132, series of 2019 and Department Order No. 102, series of 2016 (or most current versions)
