**What is the measure?**

Percentage of Implementing Offices with BAC Resolution of Award for at least 50% of its Eligible Procurement Projects (EPP) under its indicative Annual Procurement Plan (APP) Non-CSE (Common-Use Supplies and Equipment) by end of the year

**What strategic objective is the measure aligned?**

Expedite procurement process

**What is the rationale behind the measure?**

To conduct early procurement activities in line with the IRR of Republic Act (RA) 9184. This core process will enable the monitoring of Implementing Offices to readily award their contracts upon approval of the GAA.

**How is the measure calculated? Clarify the terms in the formula**

$$\%^1 = \frac{\text{No. of IO with BAC Resolution of Award (RoA) for \%^2 \text{ of EPP per Office under indicative APP Non-CSE}}{\text{No. of Implementing Offices}} \times 100\%$$

$$\%^2 = \frac{\text{No. of BAC RoA}}{\text{No. of EPP}} \times 100\%$$

Legend: EPP = Projects undertaken through competitive bidding, and alternative methods of procurement, except for: Repeat

Order; Shopping; Negotiated Procurement (Emergency Cases, Take-Over of Contracts, and Small Value Procurement)

RoA = Short of Award

Implementing Offices = Offices undertaking early procurement based on National Expenditure Program (NEP).

**What is the measure?**

Percentage of Implementing Offices (IOs) awarding 100% of the total number of its Procurement Projects under Final APP-Non-CSE (Updated 1st Semester) with releases as of end of 1st semester by the end of the 3rd quarter

**What strategic objective is the measure aligned?**

Expedite procurement process

**What is the rationale behind the measure?**

To require the Implementing Offices to immediately award the contract upon effectivity of the GAA. This core process will ensure early completion of all procurement activities and to allow for the conduct of early procurement activities for the next fiscal year before the end of the current year.

**How is the measure calculated? Clarify the terms in the formula**

$$\%1 = \frac{\text{No. of IO with Resolution of Award (RoA) for \%^2 \text{ of its PP by the end of 3rd quarter}}{\text{No. of Implementing Offices}} \times 100\%$$

$$\%2 = \frac{\text{Total No. of PP with RoA by end of 3rd quarter}}{\text{Total No. of PP}} \times 100\%$$

Legend:

PP = projects under Final APP-Non-CSE (Common-Use Supplies) (Updated 1st Semester) with releases as of end of 1<sup>st</sup> semester

RoA = Approved by HoPE

Implementing Offices = Implementing Offices under General Appropriations Act (GAA).

The number of Awarded Contracts shall be based on Civil Works Application (CWA) and verified if posted in the DPWH website. The number of projects with releases shall be requested for verification from the Finance Service.

Requirement for the high percentage of awarded contracts and absorptive capacity by the end of the year

**Who is accountable for the targets?** (target: awarding 100% of the total number of its Procurement Projects under Final APP-Non-CSE (Updated 1st Semester) with releases as of end of 1st semester by the end of the 3rd quarter) Implementing Offices/BAC
