SUBJECT: Authorities and Areas of Responsibilities of DPWH Key Officials

In the interest of the service and pursuant to the pertinent provisions of E.O No. 124, series of 1987, and in the approved DPWH Rationalization Plan pursuant to E.O. No. 366, Series of 2004, the authorities and responsibilities of DPWH Undersecretaries and Assistant Secretaries are hereby amended as follows:
