SUBJECT: Creation of a Steering Committee for Marawi City Ring Road under Road Network Development Project in Conflict Affected Areas in Mindanao

In order to develop, construct, and improve about 174.50 kilometers of access roads connecting the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM) and other regions in Mindanao and to provide support with the developmental objectives in areas affected by the Marawi siege, the Department, thru its *Build Build Build* Program, is implementing the Road Network Development Project in Conflict Affected Areas in Mindanao (RNDP-CAAM), composing of nine (9) sub-projects.

Among the sub-projects is the construction of Marawi City Ring Road, captioned as Sub-Project 7, aims to provide a trunk road which would expand capacity and improve flow of traffic in the area, spanning about 19.8 kilometers in the City of Marawi and the nearby municipalities of Marantao, Piagapo, and Saguwaran, all in the province of Lanao del Sur.

To ensure the efficient and effective coordination among concerned agencies in the implementation of the Marawi City Ring Road under RNDP-CAAM, a Steering Committee is hereby created for the design and construction phases.

I. **Composition.** The Steering Committee shall be composed of the following:

Chairperson / Convenor	: Undersecretary for UPMO Operations
Vice-Chairperson	: Minister , BARMM – Public Works Governor , Province of Lanao del Sur
Members	: Project Director , Roads Management Cluster I (Bilateral), Unified Project Management Office (UPMO) Director , Bureau of Maintenance Director , Bureau of Design Director , Bureau of Construction Project Manager-in-charge , Roads Management Cluster I (Bilateral), UPMO Overall Project Coordinator , Marawi Roads Project Senior Staff , Woodfields Consultants Inc., Consultant for Detailed Engineering Design Senior Staff , Consultant for Construction Supervision
Provisional Members	: Mayor , City of Marawi Mayor , Municipality of Marantao Mayor , Municipality of Piagapo Mayor , Municipality of Saguwaran

The Committee may assign representative/s and may invite other official/personnel from other concerned agencies to participate and/or provide assistance, as the need arises.

The Committee shall be assisted by the project team from Roads Management Cluster I (Bilateral), UPMO.

II. **Functions.** The Steering Committee is tasked to undertake the following duties and responsibilities, to wit:

1. Participate in sharing information and discussing issues, existing and potential problems, and concerns that may arise on the course of the implementation;
2. Coordinate with all concerned stakeholders thru conduct of meetings and public consultations to the concerned entities and other government agencies on all matters related to its implementation;
3. Ensure that all stakeholders involved or affected are consulted and briefed prior to implementation; and
4. Provide trainings for Operation and Maintenance activities such as conduct of Seminar on Technology Transfer and such.

The Committee shall hold coordination meetings and be notified by the Convenor or his delegated personnel to discuss matters concerning its implementation.

This Order shall take effect immediately.
