SUBJECT: Reconstitution of the DPWH -Philippine Government Asset Management Policy (PGAMP) Committee, Technical Working Group (TWG) and Secretariat

In accordance with the implementation of the Philippine Government Asset Management Policy (PGAMP) as stipulated under the Joint Memorandum Circular (JMC) No. 2020-1 dated September 24, 2020 of the Department of Finance (DOF)-Department of Budget and Management (DBM)-National Economic and Development Authority (NEDA), and improvement of the overall Asset Management System (AMS) of this Department, the DPWH PGAMP Committee, Technical Working Group and Secretariat are hereby reconstituted as follows:

The DPWH PGAMP Committee shall undertake the following functions:

- 1. Oversee the Department's overall AMS implementation from acquisition, usage, operation, maintenance, transfer, and disposal of DPWH assets
- 2. Ensure optimal utilization of the DPWH assets through consistent monitoring and documentation of asset information, operation and maintenance processes
- 3. Identify the resources needed to strengthen and improve the Department's AMS
- 4. Formulate the 2-year Asset Management Plan, named Agency Asset Management Plan (AAMP), which shall be updated annually and rolled forward. The plan shall include, among others, the following:
 - a. budgeted acquisition of assets
 - b. disposal and rehabilitation/repairs
 - c. capability development activities
 - d. needs assessment activities
- 5. Oversee the implementation, monitoring and evaluation of the AAMP
- 6. Coordinate and represent DPWH in all inter-agency PGAMP Activities

The Chairperson of the Committee shall act as the DPWH Focal Person, primarily in charge of the coordination and consultation with the PGAMP oversight agencies (DOF, DBM, NEDA and Bureau of Treasury), as well as other Institutions, Offices and Stakeholders to ensure the consistency and quality of the AAMP.

Accordingly, the DPWH PGAMP TWG will assist and provide technical and legal support to the DPWH PGAMP Committee, and shall be composed of the following:
