SUBJECT: CREATION OF THE DPWH TECHNICAL WORKING GROUP (TWG) FOR THE PLANNING COMMITTEE OF THE PHILIPPINE DEVELOPMENT PLAN (PDP) 2023 - 2028

In view of the planned formulation of the PDP 2023-2028, the country's blueprint for national development, the NEDA Board Committee on Infrastructure – Technical Board (INFRACOM-TB) has invited the DPWH to Chair the Planning Committee for Chapter 13 (Expand and Upgrade Infrastructure) of the PDP. Given the scope of the infrastructure sector, the INFRACOM-TB has divided the Planning Committee into three (3) sub-committees: (a) Digital and Physical Connectivity; (b) Water Resources; and (c) Energy.

The Digital and Physical Connectivity sub-committee and Water Resources sub-committee will be chaired by **Undersecretary Maria Catalina E. Cabral, PhD.**, with **Assistant Secretary Constante A. Llanes, Jr.**, Planning Service and **Assistant Secretary Eric A. Ayapana**, Information Management and Technical Services, as the alternate representatives, respectively.

To assist the Department in the crafting of its targets and inputs for the PDP 2023 – 2028, the Technical Working Group (TWG) for the sub-committees are hereby created. The TWG Planning Committee for the Physical and Digital Connectivity shall be composed of the following:

Whereas, the TWG Planning Committee for the Water Resources shall be composed of the following:
