In consideration for the sum of **Eight Million Six Hundred Eighty Seven Thousand Two Hundred Fifty Pesos Only (P 8,687,250.00)** or such other sums as may be ascertained, **BHENLLABIEN BUILDERS CORPORATION (Formerly: BHENLLABIEN BUILDERS CONSTRUCTION)**, agrees for the execution and completion of the works and remedy of any defects therein in accordance with his/her/its Bid.
  4. The DPWH Laguna 3<sup>rd</sup> District Engineering Office agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
