In consideration for the sum of **Fifty Six Million Four Hundred Fifty Two Thousand One Hundred Eighty Five Pesos Only (P56,452,185.00)** or such other sums as may be ascertained, **EDDMARI CONSTRUCTION AND TRADING** agrees for the execution and completion of the works and remedy of any defects therein in accordance with his/her/its Bid.
4. The DPWH Laguna 3<sup>rd</sup> District Engineering Office agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
