WHEREAS, the Entity is desirous that the Contractor executes **CSSP -

 - (g) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Nine Million Five Hundred Fifty Five Thousand Pesos Only (₱ 9,555,000.00)** or such other sums as may be ascertained, **N.D.M. SANCHEZ BUILDERS & DEVELOPMENT CORPORATION** agrees for the execution and completion of the works and remedy of any defects therein in accordance with his/her/its Bid.
4. The DPWH Laguna 3rd District Engineering Office agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
